



# THE SUZUKI 11.11 AUCTION: TERMS & CONDITIONS

- 1. These Terms and Conditions apply to all participants of the Suzuki Champion Auction (the "Auction"). The organiser of the Auction is Champion Motors (Singapore) Pte Ltd (the "Organiser").
- 2. Words denoting the singular shall include the plural and vice versa.

# ELIGIBILITY OF ENTRY

- 3. The Auction is open from 11 November 2023 at 0700 hours to 14 November 2023 at 2359 hours (the "Auction Period").
- 4. The Auction is open to all Eligible Participants. By participating in the Auction, all participants are deemed to have unconditionally agreed to be bound by these Terms and Conditions and the decisions of the Organiser, which shall be final and binding in all respects.
- 5. "Eligible Participants" means all residents of Singapore who are aged eighteen (18) years old or above with a valid driving license at the time of entry and excludes the following:
  - a. employees of the Organiser and affiliated companies and members of their immediate families;
  - b. any other persons that the Organiser may decide to exclude at its sole and absolute discretion without notice and without furnishing any reason.

## HOW TO ENTER

- 6. To participate in the Auction, participants are required to place a bid on <u>auction.suzukicar.com.sg</u>, complete the registration form and pay a deposit of SGD500 during the Auction Period.
- 7. All submissions must be submitted by 2359 hours (SGT) on 14 November 2023. Any entries received thereafter will not be eligible for consideration. Participants who wish to bid again are required to pay a deposit of SGD500 and place their bid again. In the event, a participant chooses to submit multiple bids revision, only the highest bid per participant will be eligible as the winning bid and the deposit for the remaining bids will be refunded in accordance to clause (8) below.
- 8. Successful bidders will be contacted directly. The deposit of SGD500 will be refunded to participants with unsuccessful bids within 30 days from the end of the Auction Period.





### **DETERMINATION OF SUCCESSFUL BIDS**

- 9. The Organiser will, in its sole and absolute discretion, select the winning bids (the "Winning Bids") on 16 November 2023 onwards. The decision of the Organiser will be deemed as final and irrefutable. Auction winners will be notified at the email address or contact number provided at the time of bidding ("Auction Winners"). The Auction Winners will be awarded vehicles based on their chosen exterior colour in the Winning Bids, subject to availability.
- 10. To claim their Winning Bid items, Auction Winners will need to make payment for the Winning Bid item(s). Once the Organiser has secured your \*COE (\*Subject to 3months / 6 bids non-guaranteed COE), registration must be done within the same month. If the Auction Winner fails to do so or does not fulfil any of the Terms and Conditions hereunder, their deposit shall be forfeited, and the Auction Winner shall be deemed to have forfeited all rights to the Winning Bid items and the Organiser shall have the sole and absolute discretion to award the Winning Bid items to the next qualifying participant.

- 12. All successful bidders with COE secured must register the car on/before 24 December 2023. Failing which the bidders must pay for the differences in VES changes.
- 13. All bids are non-transferable, and no substitution will be made unless the Organiser, in its sole discretion, determines otherwise. The Organiser reserves the right to substitute a Winning Bid items for one of equal or greater value should it become unavailable for any reason.
- 14. In the event that the Auction Winner(s) chooses not to accept the Winning Bid items that they have bidded for, they forfeit any claims to the Winning Bid items, which can then be awarded to another participant chosen at the sole discretion of the Organiser.

# **CONDITIONS OF ENTRY**

- 15. All taxes, fees and surcharges are the sole responsibility of the Auction Winners. Failure to comply with the Terms and Conditions herein will result in forfeiture of the Winning Bid items. The Organiser reserves the right, in its sole and absolute discretion, to award a substitute item of equal or greater value if a Winning Bid item described is unavailable or cannot be awarded, in whole or in part, for any reason.
- 16. To the fullest extent permitted by law, the Auction Winners shall release the Organisers, its partners, related and affiliated entities and other third parties involved in the organisation, promotion or administration of the Auction and their respective officers, employees, agents or contractors against any and all claims, costs, rights, demands, losses, damages, causes of action and liabilities of any kind arising out of the acceptance and use of any Winning Bid items(s) or entry into the Auction, including but not limited to any loss of income, personal injury, damage to property and whether direct or consequential, foreseeable, due to a negligent act or omission or otherwise.
- 17. The Organiser also reserves the right at its sole discretion to disqualify from this Auction, and any future auction or other promotion the Organiser conducts, any participant that it finds or believes to be tampering with the bidding process, or the operation of the Auction or Auction website, or to be acting in breach of these Terms and Conditions or in an unsportsmanlike or disruptive manner, or with intent to annoy, abuse, threaten or harass any other person.
- 18. Any attempt by a participant or any other person to deliberately damage any website used in association with the Auction, or undermine the legitimate operation of the Auction may be a violation of criminal and civil laws and should such an attempt be made, the Organiser reserves the right to seek damages from any such person to the fullest extent permitted by law.





## **COLLECTION. USE AND DISCLOSURE OF PERSONAL INFORMATION**

- 19. By entering the Auction and/or voluntarily providing his/her personal information, each entrant consents and agrees to the collection, use and disclosure of the entrant's personal information by the Organiser and/or its partners and/or other affiliated or third parties directly involved in the organizing, promoting or conducting of the Auction for the purpose of administering the Auction and fulfilling the Winning Bid items. The Organiser will not use an entrant's personal information for any other reason, nor will the Organiser otherwise disclose it to any third party without consent of entrant. - 20. By participating in the Auction, each participant warrants that all personal details, answers, responses and/or entries submitted to the Auction are the participant's own information and are true and/or accurate. Where the participant provides any personal data relating to a third party or concerning another individual other than the participant, the participant represents and warrants to the Organiser that all necessary consents have been obtained from the relevant individuals to the collection, retention and/or use of their personal data for the purposes set out in the Terms and Conditions herein, and/or for the relevant purpose for which the personal data is collected. Participants agree to indemnify and keep indemnified the Organiser and its partners who organize, promote and administer the Auction against all claims, losses, damages and/or expenses whatsoever arising from any infringement or violation of any third party's rights in relation to their participation in the Auction.

#### **INDEMNITY**

1. Participants shall indemnify the Organiser and its partners who organise, promote and administer the Auction against all costs, expenses, damages, liability or injury incurred by the Organiser and its partners who organise, promote and administer the Auction arising out of or relating to the participant's entry into the Auction and/or the participant's acceptance, use or misuse of the Winning Bid items, including but not limited to any of the participant's acts, omissions, statements, publications whatsoever as may be in breach of any law or legal rights, as the case may be.

In such event, the Organiser shall immediately suspend all entries and/or Winning Bid items awards, and the Organiser reserves the right to award any remaining Winning Bid items in a manner deemed fair and equitable by the Organiser. The Organiser shall not have any further liability to any participant in connection with the Auction. The participants agree that the Organiser and its partners who administer the Auction shall not be responsible or liable, directly or indirectly, for any damage or loss caused or alleged to be caused by or in connection with the Auction or the use of or reliance on any such content, goods or services available on the Organiser's and its partners who administer the Auction and its respective social media platforms and website used in connection with the Auction. The participants further agree that the Organiser shall not be responsible or liable for any losses or injuries of any kind resulting from participating in the Auction or acceptance, possession and/or use or misuse of the Winning Bid items, or any part thereof, and agree to release, discharge and hold harmless the Organiser and its respective officers, directors, parent companies, subsidiaries, affiliates, related

  - c. substitute, withdraw or cancel any Winning Bid items without disclosing any reason and without any payment of compensation whatsoever.

If any act, omission, event or circumstance occurs which is beyond the reasonable control of the Organiser, and which prevents the Organiser from complying with these Terms and Conditions or providing the Winning Bid items, the Organiser will not be liable for any failure to perform or delay in performing its obligations.
- 6. All date and time references are based on Singapore GMT +8 Standard Time Zone.
- 7. These Terms and Conditions shall be governed and construed in accordance with Singapore Law and the parties agree to submit to the exclusive jurisdiction of the Singapore Courts.
